## COVID-19

Due to the COVID-19 pandemic special rules apply, having our offered services differentiated for the current period. Following health and safety instructions that occasionally are issued, our purpose is to provide and ensure a safe access to our sport.

All members, with access at the squash courts at "Tassos Papadopoulos-Eleftheria" sports center, are obliged to comply with all relevant rules and instructions, as well as to consent to point 6 of the NSA clarifications. In different access will be denied and this application will not be proceeded.

- Members, who were inactive before the adoption of the new Articles of Association, will be considered as already registered-regular members and will be included in the new registry of members that was activated on September 1, 2013.

## 4. NSA Payment policy

### 6. CONSENT FOR KEEPING RECORDS AND SUBMISSION OF DATA TO AUTHORITIES

Implementing the guidelines and precautions issued by the Cyprus Ministry of Health for the new coronavirus (SARS-CoV-2), the Nicosia Squash Association is obliged to keep records for the users of the courts. These records refer to the name and telephone number of all entering the courts and the adjacent spectator area and are submitted daily to Cyprus Sports Authorities for tracing purposes.

Therefore, for your access to the courts, you need to consent to this. In a different case, your application will be denied, and not be examined.
